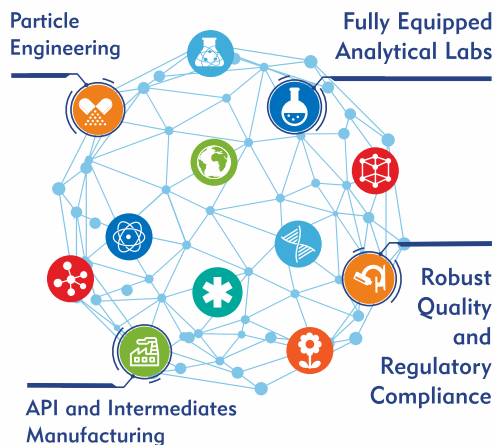
At Coral we believe that we are not just making APIs, we are creating a world where people can live safe and healthy lives.

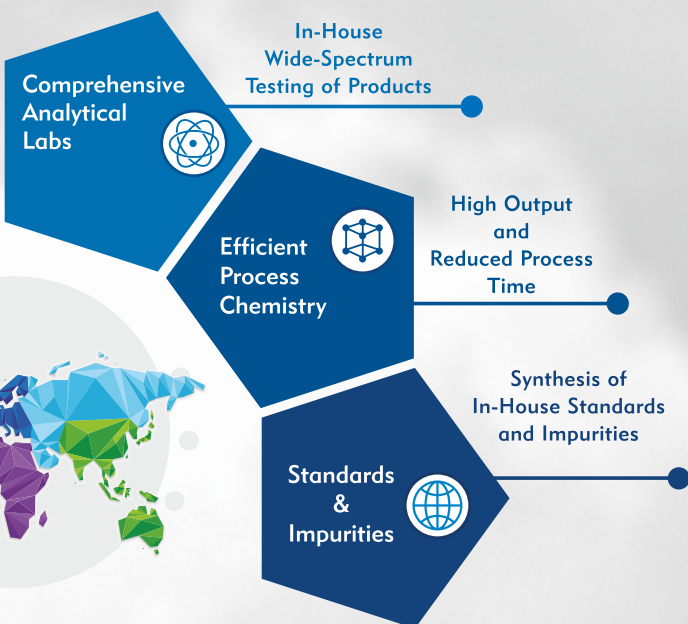

We realise that particle size can impact the bioavailability and the dosage form of every API, as well as dissolution, absorption rate and content uniformity. At Coral, through a two-tiered process, we ensure to deliver the correct particle size every time.

Firstly, we ensure that the correct particle sizes are produced. Whether it is controlled by our chemical processes or a variety of milling and grinding techniques, our manufacturing facilities are well equipped for practically any challenge. Once the product is milled and ready, the next step is to measure the particles to ensure that they are of the correct size.

We believe that the most important aspect of any particle size analysis is the development of a rugged and reproducible method of analysis. Our team spends countless hours developing methods that minimize particle agglomeration by using a range of compatible surfactant and non-soluble dispersant media.

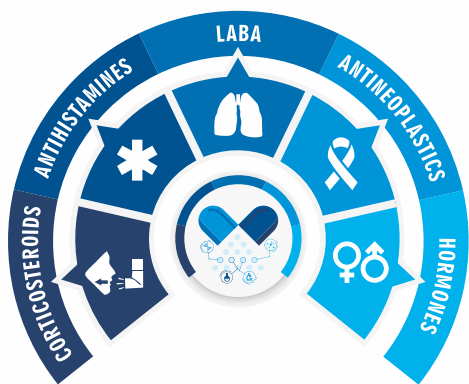
